- **Color Requirements for 4-Color Process:** Recommended –133 line screen. Only digital files accepted. Documents must contain at least 3 sets of register marks placed 1/4" outside image area. Not responsible for poor legibility of white type 10 point and under caused by color filling in type. Reverse type must be spread in all color plates other than the dominant plate that defines the type. Maximum screen densities of tone not to exceed 280% in any print area. Color proofs must accompany color files.
- **Material for Bleed Ads:** Type or illustrative material not intended to bleed must be kept 1/4" from top, bottom, and each side. Live matter on fac-

ing pages (spreads) should not be closer than 1/8" from the center fold on each page, providing a total separation of 1/4".

- **Ad Size and Construction:**

Non-Bleed Ads: the page or document size should equal the trim size. Content should not exceed non-bleed dimensions.

Ads with Bleed: the page or document size should equal the trim size with bleed extending at least 3/16" beyond trim on all sides. Please keep in mind: When sending your ad as a flattened image (i.e. PDF, EPS or TIF), the page or document size should equal the bleed size.

- **Production Charges:** No charges when one piece, correct size documents are supplied. Hourly charges (1/2-hour mini-

mum) will apply for alterations we make to your files due to errors in ad size, type, color space, or file format.

- **Acceptable Proofs:** MatchPrint™, EPSON POLAPROOF™, or KODAK APPROVAL™. If ad is 4-color and an accurate color proof is not provided by the advertiser, printer will run color according to SWOP standards.
- **Preferred File Format:** Adobe® Acrobat® PDF-X1A files delivered to <http://www.ads4reed.com/>.
- **Raster File Resolution (Photos):** 266 DPI (at final size) saved in TIFF or EPS format. Do not compress graphics using JPEG or LZW.
- **Color:** Color images should be converted and saved in CMYK format only, unless a matched Pantone® color has been purchased. RGB, Indexed and LAB colors are not acceptable. All embedded color profiles (ICC) should be removed before creating PDF file.
- **Graphics:** Embed images in your file when saving in PDF format. Remove all embedded color profiles (ICC) before embedding graphics.
- **Ad Size:** Crop marks for full page ads should be at trim size. Bleed ads should extend beyond trim crop marks by 3/8 inch. Fractional ads should be set up exactly to [trim] sizes speci-

fied by publisher.

- **Trapping:** Do not trap files. Trapping will be set automatically through Reed's graphic production department.

- **Fonts:** Embed fonts in your document before creating PDF file. Please use Adobe Type 1 fonts only. Do not use Multiple Master, True Type or CID Identity-H fonts!

- **Common Problems Associated with Digital Files:**

Composite Fonts: Do not "export to PDF". Document must be postscripted, then distilled.

Fonts not embedded: Embed all fonts in your document before creating PDF file.

Transparencies and Gradients: Convert gradients to smooth shades. Transparencies needs to be "flattened" before the PDF file is created. To do this, follow these guidelines: If this file was created in **InDesign** you must change your document's Transparency Flattener Style to the following settings: Flattener Level: High, Flattener Resolution: 2400, Gradient Resolution: 600, Force Text to Outlines: Off, Convert Strokes to fills: Off, Clip Complex Regions: On. If this file was created in **Illustrator**, go to Document Setup, choose the "transparency" setting, make sure the raster/vector balance under

flattening settings is 100, and the rasterization resolution is 300ppi. As a precautionary measure, convert all text and strokes to outlines, click OK. Then select all objects in your document, go to Object>Flatten Transparency, select "convert all strokes to outlines" and hit OK. If this file was created in **Photoshop**, go to Select, choose All. Then go to Layer, choose "flatten image", click OK.

PDF Library is used: Do not "save as PDF". Document must be postscripted, then distilled.

Resolution is Below Threshold: Images must be 266dpi at final size (150 dpi at the absolute minimum).
